## **Invitation for Negotiated Procurement for the Establishment and Upgrade of Three Command Centers**


1. In view of two failed competitive biddings, the Police Regional Office 1, through its Bids and awards Committee (BAC), invites interested bidders to participate in the negotiation for the Establishment and Upgrade of Three Command Centers with an Approved Budget for the Contract (ABC) of Twenty-Four Million Five Hundred Sixty-Two Thousand Eight Hundred Ninety Pesos (P24,562,890.00) in accordance with Section 53.1 of the 2016 Revised Implementing Rules and Regulation of Republic Act No. 9184, otherwise known as the "Government Procurement Act.
2. Delivery of the Goods is required within 30 days from receipt of Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183
4. Prospective Bidders may obtain further information from Police Regional Office 1 and inspect the Negotiated Procurement Documents at the address given below during 8:00 AM to 5:00 PM.
5. A complete set of the Negotiated Procurement Documents may be acquired by interested Bidders on June 4 to 14, 2022 from the given address and website(s) below.
6. The Police Regional Office 1 will hold a Negotiation Conference on June 9, 2022 at 2:30 PM at PRO 1 Conference Room, Camp BGen Oscar M Florendo, Parian, City of San Fernando, La Union and/or through video conferencing or webcasting via Zoom Video Communications, which shall be open to all interested bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before June 14, 2022 at 2:30 PM. Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on June 14, 2022 at 2:30 PM at PRO 1 Conference Room, Camp BGen Oscar M Florendo, Parian, City of San Fernando, La Union. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The Police Regional Office 1 reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
